National Institute of Social Development Annual Report - 2014

01. Preamble

The National Institute of Social Development has been incorporated by an Act of Parliament bearing No. 41 of 1992. Its inception can be attributed to the "Institute of Social Work" setup in 1952 by a group of voluntary organizations. It was later taken over by the Government in 1964 and renamed as "Ceylon School of Social Work."

Our Vision

The vision of the Institute is "to be a centre of excellence nationally and globally in Social Work Education, Training and Research."

Our Mission

The mission of the National Institute of Social Development is "To enhance human resources for social development through the preparation of competent manpower in social work at all levels, generate and disseminate new knowledge and technologies for social work practice, provide specialized services for social welfare and social development.

Objectives of the Institute

The objectives of the institute, as stated in the National Institute of Social Development Act. No. 41 of 1992 are to:

- 01. Upgrade, expand and update higher educational programmes for professional social work, social welfare management & social development upto the globally recognized standards.
- 02. Expand, strengthen and collaborate in training programmes aimed at human resources development for social welfare, human services, community development empowerment of disadvantage and social development while increasing avenues for those who are interested in developing and advancing their skills in the field of social work to optimize and better perform their careers with competency.
- 03. Înitiate, promote, conduct and collaborate In research work pertaining to various aspects of social work education and practices, social welfare and social development whilst generating and propagating new knowledge pertaining to the field for present and future application.
- 04. Contribute to the social welfare and social development policy formulation, planning and implementation through the provision of specialist services.
- 05. Improve financial, academic, non academic manpower and infrastructural resources with special attention to the establishment of a permanent premises for the institute to facilitate the achievement of all other goals.

The Institute is engaged with the following activities to achieve the above objectives:

- 01. Providing professional social work education,
- 02. Conducting of local and international training programmes in social work.
- 03. Conducting research in the field of social work, social welfare and social development and publishing literature
- 04. Conducting counseling services in the field of social welfare,
- 05. Developing professional and managerial efficiency of the staff of Government and Non-Governmental sectors involved in social welfare
- 06. Providing necessary assistance to the Hon. Minister to formulate and implement social welfare policies and programmes.



The programmes of the National Institute of Social Development are as follows:

- 01. Curriculum development, organizing, conducting and field work coordination of degree programmes, diploma programmes and para-professional training programmes in social work.
- 02. Improving, conducting and undertaking research on social welfare and social policy.
- 03. Publishing literature on social work
- 04. Conducting seminars and workshops with financial aids from foreign and local organizations to enhance the professional and managerial competence of officers of Government and Non-Governmental Organizations involved in social welfare activities.
- O5. Assisting the Hon. Minister to determine policies at staff meetings and discussions attended by him and submitting written proposals for him to plan and implement social welfare programmes.
- 06. In implementing social welfare plans in Government and Non-Governmental sectors, assigning social work students to those institutions through their projects. Providing necessary guidance and advice for their development. Conducting consultancy meetings and conferences to make their services more productive.

A review

National Institute of Social Development was established on 29th April 1952. The National Institute of Social Development is recognised by the University Grants Commission (UGC) as a degree awarding Institute, under section 25 of the Universities Act No. 16 of 1978. It functions under the purview of the Ministry of Social Services. Currently it is conducting many educational, Training and Research Programmes for the Social Development and Social Welfare of the country. Currently regular operational functions of this Institute are carried out by four integrated divisions, namely, School of Social Work, Training division, Social Policy, Research and Publications division and Administration and Finance division.

The Diploma in Social Work, Bachelor's Degree programme in Social Work, Masters' Degree in Social Work are the major educational programs conducted by the School of Social Work. In addition to Social Work education, Diplomas in Women Empowerment, Child Protection and certificate courses are also being conducted.

Several Diploma Programs including Diploma in Counseling, Diploma in Social Care are conducted by the Training Division. Higher Diploma in Counseling commenced recently with the objective of upgrading to a Degree in Counseling. The capacity building of Government Officials in the Social Development sector is done through short term and long term training courses conducted by the institute. The above courses are conducted in Jaffna, Mannar, Kilinochchi, Ampara, Vavuniya, Batticaloa, Kururnegal, Anuradhapura and Hambantota District having the Colombo as the Center.

The research and publications division has launched many researches which have contributed to the policy formulation. The books and the publications published by this division can be used for the improvement of the social development and Social welfare sectors.

There are three Regional Centers functioning in Ampara, Ranna and Thalawa and the 4th to be opened in Kilinochchi recently. The Regional Training Centers are opened with the objective of expanding the courses to the Sinhala, Tamil and Muslim communities living in various parts of the Sri Lanka.

NISD has been granted permission to upgrade the Institute to the level of university by the UGC and the Ministry of Higher Education and the activities are in progress. The measures taken to construct a building complex in Seeduva is one of the steps in the development of the organization.

NISD has been providing an immense service over the last 62 years through the Divisions, School of Social Work, Training and Research by conducting short term and long term trainings. Awareness created locally and internationally through the services provided by the National Institute of Social Development can be mentioned as a great achievement of the Institute.

Report of the Auditor General on the Financial Statements of the National Institute of Social Development for the year ended 31 December 2014 in terms of Section 14 (2) (c) of the Finance Act, No. 38 of 1971

The audit of financial statements of the National Institute of Social Development for the year ended 31 December 2014 comprising the statement of financial position as at 31 December 2014 and the statement of financial performance and consolidated cash flow statement for the year then ended and a summary of significant accounting policies and other explanatory information was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 13(1) of the Finance Act, No. 38 of 1971 and Section 18 of the National Institute of Social Development Act, No.41 of 1992. My comments and observations which I consider should be published with the Annual Report of the Institute in terms of Section 14((2)(c) of the Finance Act, appear in this report. A detailed report in terms of Section 13 (7)(a) of the Finance Act, was issued to the Director General of the Institute on 11 May 2015.

- 1.2 Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the Sri Lanka Public Sector Accounting Standards and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatements whether due to fraud or error.

1.3 Auditor's Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Sri Lanka Auditing Standards consistent with International Standards of Supreme Audit Institutions (ISSAI-1000-1810). Those Standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the Institute's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Institute's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements. Sub - sections (3) and (4) of Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and the extent of the audit.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

1.4 Basis for Qualified Opinion

My opinion is qualified based on the matters described in paragraph 2.2 of this report.

2.	Financial Statements

2.1	Qualified Opinion

In my opinion, except for the effects of the matters described in paragraph 2.2 of this report, the financial statements give a true and fair view of the financial position of the National Institute of Social Development as at 31 December 2014 and its financial performance and cash flows for the year then ended in accordance with Sri Lanka Public Sector Accounting Standards.

2.2	Comments on Financial Statements

2.2.1	Sri Lanka Public Sector Accounting Standards
	The following observations are made.

- (a) The Statement of Changes in Net Assets/ Equity had not been presented along with the accounts in terms of Sri Lanka Public Sector Accounting Standard 01.
- (b) The statement of financial position presented as at the end of the year under review had not been prepared according to the relevant format.
- (c) Even though each material class of similar items should be presented separately in the financial statements in terms of paragraph 45 of Standard No.01, income from academic programmes amounting to Rs.30,326,318 of the year under review had been shown under other income.



2.2.2 Accounting Policies

The following observations are made.

- (a) An Accounting Policy on course fees had not been established and disclosed.
- (b) Even though the Treasury had granted provisions annually for capital expenditure, a clear accounting policy had not been established and disclosed on accounting and writing off of those provisions.

2.2.3 Accounting Deficiencies

The following observations are made.

- (a) Even though the Treasury had granted a sum of Rs. 80,855,000 for recurrent expenditure in the year under review, it had been shown as Rs.80,899,000 in the financial statements.
- (b) Capital expenditure amounting to Rs. 150,509 had been brought to account as recurrent expenditure.
- (c) Even though a sum of Rs.244,080 had been paid as gratuity to an officer retired in December 2014, that amount had been debited to the Gratuity Expenditure Account instead of debiting to the Gratuity Provisions Account. As such, the gratuity expenditure had been overstated by Rs. 244,080 in the statement of financial performance of the year under review.
- (d) According to the bank reconciliation statement prepared for December in the year under review, other fees amounting to Rs.1,264,281 charged from the students for various courses credited to the bank account but not debited to the cash book, had not been brought to account as income.

2.2.4 Unexplained Differences

......

An asset amounting to Rs.6.592,425 and a liability amounting to Rs.6,362,523 had been shown as Distress Loan transfers in the statement of financial performance and the reasons for the difference of Rs.230,102 had not been revealed.

2.3 Transactions not supported by Adequate Authority

The following observations are made.

- (a) Even though a sum of Rs.4,048,400 had been paid for lectures conducted during weekends for the officers of the Institute from the fees charged for various courses during the year 2014, approval had not been obtained for that in terms of Circular No.39 of 29 May 2009 of the Department of Management Services.
- (b) Intangible assets amounting to Rs.694,118 shown in the accounts had been written off from the books of the year under review and the approval of the Board of Directors and the Treasury had not been obtained for the writing off of those assets.

2.4 Non-compliance with Laws, Rules, Regulations and Management Decisions

The non-compliances with laws, rules, regulations etc. observed in audit are as follows.

3.	Financial Review
3.1	Financial Results

According to the financial statements presented, the financial result of the Institute for the year ended 31 December 2014 had been a deficit of Rs.907,191 as compared with the corresponding deficit of Rs.7,806,700 for the preceding year, thus indicating an improvement of Rs.6,899,509 in the financial result. Increase in the Government recurrent grants by Rs.15,838,000, Government capital rehabilitation grants by Rs.3,615,866, and other receipts by Rs.34,138,402 had mainly attributed to the above increase.

4.1 Operating Review 4.1 Performance

The following observations are made.

- (a) The performance report prepared according to the Action Plan for the year under review, had been prepared by different divisions monthly and a performance report indicating the physical and the financial position for the entire Institute had not been prepared.
- (b) The Action Plan had not included the activities expected to be implemented at the Training Centres at Anuradhapura and Talawa and the Hostel at Kelaniya of the Institute during the year under review.

(c) School of Social Works

- It was observed that Examination Board Meetings had not been held relevant to 05 Degree Courses included in the Action Plan of the year under review.
- (ii) Even though it had been planned to commence Social Work Diploma Courses included in the Action Plan of the year 2014 in the districts of Anuradhapura and Ampara by the School of Social Works, those courses had not been commenced during the year 2014.

(d) Training Division

- Examination Boards had not been held relevant to two Diploma Courses on Consultation by the Training Division.
- (ii) Even though it had been planned to conduct 11 short term training programmes and provide training for 630 persons by the Training Division, only 442 persons had participated in the short term training programmes. As such, it is observed that this represents 70 per cent of the targeted number.
- (iii) The following courses and functions targeted to be achieved in the Action Plan for the year 2014 had not been carried out.
 - The short term training programme on Stress Management and Basic Psychological Consultation for prison officers
 - The short term training programme for the staff of the Kesbewa Divisional Secretariat
 - The Capacity Building Training Programme for the academic and non-academic staff of the Institute
 - Commencement of a training centre in Kandy

(e) Social Development Policy, Research and Publication Division

Out of the 12 activities which should be fulfilled according to the Action Plan of the year 2014, only 9 had been fulfilled during that year. Three activities expected to be fulfilled had not been fulfilled and 3 activities irrelevant to this division had been fulfilled.

4.2	Management Inefficiencies

The following observations are made.

- (a) The loss of Rs.86,450 sustained in respect of three vehicles that had met with accidents, had not been recovered from the responsible persons.
- (b) Even though the Treasury had granted a sum of Rs.02 million to the Institute in the year 1998 to establish a revolving loan fund, action had been taken to issue the same amount as loans without taking action to establish a loan fund.

4.3 Weaknesses in Financial Control

The following observations are made.

- (a) Payments had been made for 02 vouchers of Rs.9,000 and Rs.6,000 respectively on the instructions of the Accounting Officer without entering in the Cash Book.
- (b) Even though a sum of Rs.918,000 had been paid to a building owner as Value Added Tax for the building at Narahenpita in which the Institute is operated, the registration of the owner for Value Added Tax had not been confirmed.
- (c) A sum of Rs.35,287 had been paid to the Welfare Association of the Institute in the year under review.

4.4 Uneconomic Transactions

.....

A sum of Rs.150,000 had been paid by the Institute in the year under review for the 47th anniversary and Technological Workshop of the Sri Lanka Association of Professional Social Workers.

4.5 Identified Losses

A loss of Rs.153,166 had been sustained due to an accident caused by the owner of a private security service by driving a vehicle of the Institute inside the premises and a sum of Rs.111,276 had been received from the Insurance Company. The balance sum of Rs.41,890 had been shown as repair expenses without recovering from the relevant person.

4.6 Personnel Administration

The following observations are made.

- (a) Vacancies of 22 per cent and 10 per cent existed in the academic staff and the non-academic staff of the Institute and one person of the academic staff had left abroad. Eight persons had been recruited in the year under review for the nonacademic staff on easual basis on the approval of the Board of Control.
- (b) Duties had not been assigned in writing to the officers of the Training and Research Division of the Institute and research officers and three research assistants had been engaged in the duties relevant to the posts of Management Assistant outside the Research Division.



4.7 Resources of the Institute given to other Government Institutions

A sum of Rs.367,628 had been paid as salaries, travelling expenses and overtime in the year under review to an officer of the Institute, released to the Ministry of Social Services contrary to Section 8.3.9 of the Public Enterprises Circular No. PED/12 of 02 June 2003.

5.	Accountability and Good Governance
5.1	Budgetary Control

- (a) Even though the Projected Income Statement and the Balance Sheet should be prepared and presented as the Budget in terms of Section 8(3) of the Finance Act, No.38 of 1971, an income statement had not been prepared using the approved format and a statement of projected financial position had not been prepared as well.
- (b) Even though the Institute had recovered a sum of Rs.31,271,645 by conducting courses in the year under review, the income expected to be earned by conducting courses had not been included in the budget prepared for the year 2014. Moreover, the Institute uses the earnings of the Institute in addition to the Treasury provisions for expenses. However, the details relevant to it had not been included in the budget, thus indicating that the budget had not been made use of as an effective instrument of management control.

6. Systems and Controls

Deficiencies in systems and controls observed during the course of audit were brought to the notice of the Director General of the Institute from time to time. Special attention is needed in respect of the following areas of control.

- (a) Accounting
- (b) Stock Control
- (c) Income Control

2.2 Comments on Financial Statements

2.2.1 Non Compliance with Sri Lanka Public Sector Accounting Standards

- (a) Changes in net assets/ equity had been shown in the accounts, However, it had not been disclosed as a statement due to an oversight. Noted to rectify it in accounts of the ensuing years.
- (b) The financial position statement has been furnished so as to the format concerned. Noted to furnish a correct financial position statement in future by obtaining your instructions, provided if there are shortcomings, if any.
- (c) As the academic programme expenditure had been shown in the face of the income statement and considering the adequacy of income, the income from academic programme amounting to Rs.30,326,317.78 could have been shown on the face of the income statement. However, attention had not been paid in this regard.

2.2.2 Accounting Policies

- (a) Noted to adopt accounting polices in the ensuing years and to disclose them.
- (b) Preparation and accounting of accounts had been shown. Noted to disclose accounting policies as per instructions given by you in future accounting years.

2.2.3 Accounting Deficiencies

- (a) The Treasury grant for recurrent expenditure for the year 2014 has been shown as Rs.80,889,000. The excess sum of Rs.34,000 received refers to provision obtainedfrom the Treasury (2013). It has been entered as receipt in the cash book during 2014 and hence the overstatement of Rs.34,000.
 - This receipt from the Treasury is for the year 2013 and this extra amount had been utilized as for the Treasury expenditure in 2014.
- (b) Noted to rectify in future accounting years.
- (c) Noted to rectify Gratuity Accounts.



(d) This sum of Rs.1,269,280.96 could have been treated as income. But, it was unable to identify the entry of income into the accounts at that juncture. However, by now, all the amount had been correctly noted as income.

2.2.4 Unexplained Variations

Noted to properly maintain distress loan accounts, than at present, as instructed by you.

2.3 Transactions without Adequate Authority

- (a) As instructed by you, action had already been taken to obtain approval from the Department of Budget and the Department of Management Services with the approval of the Board of Directors for payment of these fees. It will be informed to you no sooner it is received.
- (b) This sum of Rs.694,118 refers to a computer licence received from another non governmental organization. It has been received as grant over 5 years ago and it has been accounted for, at the value prevailed then. However, no duties had been carried out at this Institute by using such a licence. This has been continuously shown in the accounts with 'nil' value. As such, this had been written off by disclosing it as an accounting policy. Noted to obtain the approval of the Board of Directors when such a write off occurs in future.

2.4 Non compliance with Laws, Rules, Regulations and Management Decisions

(a) Financial Regulations

- (i) Preparation of complete reports and preliminary reports relating to accidents had been commenced since January 2015.
- (ii) A register of losses and damages is being maintained from January 2015.

(b) Public Administration Circular

(i) A mobile telephone for Rs.37,750 had been purchased for official duties of the Director General with the approval of the Secretary to the Ministry. The recommendations of the Ministry could be considered in this regard and suitable action will be taken regarding discrepancies, if any, in future. The ministry had informed that a reply relating to this could be furnished by them.



- (ii) Concessions granted contravening (i) and (ii) of Paragraph 2 of the Circular No.3/92 of 257/1/1972 had been suspended forthwith.
- (c) The register of fixed assets has been updated since 2013 in accordance with the Treasury Circular No.842 of 19 December 1978.
- (d) This person was appointed on the basis of paying a monthly allowance with the approval of the Board of Directors as an officer was required to look after the Divisional Training Centre, a very important matter for which a person could not be recruited by then. Action would be taken not to engage in such activities in future. This allowance is not being paid at present as a permanent officer has already been appointed.
- 03. Financial Review

3.1 Financial Results

While considering the matters pointed out by you in 2014, I would like to explain that the deficit of 2013 had extensively decreased by Rs.6,899,509 in 2014 showing a vast progress of the Institute along with its consistent existence and the services of employees had been made use of, effectively.

04. Operating Review

4.1 Performance

- (a) All physical and financial position are depicted in the annual report prepared. Noted to take action regarding any changes needed, if any, and how it should be done.
- (b) Plans relating to this had been included in the Revised Action Plan for the year 2014.
- (c) School Social Services

(i) Reasons for the delay of 2 months with reference to the Examination Board pertaining to Social Work Degree Course 2010/2014 (English /Medium), 2011/2015 (English Medium), 2012.2016 (English Medium), 2013/2017 (Sinhala, English and Tamil Medium) are as follows.



The number of degree courses had increased at present and there is a dearth of members in faculties to cope with this and as such the work load of the members of faculties had increased and this had resulted in a delay of examining the examination question papers. As such, there was a delay of about 2 months in marking papers by the examination board, New recruitments had been made recently and action had been taken in such a manner so that such delays would not occur in future.

Delay in examination boards, problems caused by allocating a prominent examination hall in a place like BMICH, Presidential Elections held in January 2015 etc., were the practical difficulties which caused the delay in convocation of degrees.

(ii) Social Work Diploma Course included in the Action Plan 2014 was planned to be commenced in the following districts. However, the number of course participants was not adequate as planned and the course could not be commenced during the year 2014. The number expected was 40-50. But, the number of applications received were less.

Meanwhile, this course is planned in such a manner so that it could be conducted by collecting money from participates, If it is unable to include 40-50 students per course it becomes unable to conduct the course. As such, the course cannot be commenced with lesser participants.

The Social work Diploma Course planned to be commenced in the Jaffna District in 2014 had commenced in December 2014.

(d) Training Division

(i) Diploma Course in Teaching (Tamil Medium) Jaffna 2012/2014

According to the decision taken by the National Institute of Social Development, certificates are awarded only once a year. (with the intention of minimizing expenditure). Accordingly, results of many courses are released when certificates are to be awarded. As such, the award of certificates (2012/2014) had been delayed. However, the final results and the detailed results had been issued to the students as the examination board had concluded its work and as such the students who followed the courses had not been affected.



• Diploma Course in Teaching (Tail Medium) Thalawa 2013/2014

The main problem occurred during the course conducted at the Thalawa Centre was the difficulty in obtaining field supervisors in the area (North Central). It was revealed at the review meeting that the students were unable to complete the field training during the period concerned. Accordingly, it was decided to allocate extra time to complete the field training and as such the examination board could not function as planned.

• Diploma Course in Teaching (Sinhala Medium) Thalawa 2013/2014

The period granted for the field training pertaining to this course, namely Diploma Course in Teaching (2013/2014 – NW Training Centre) was more than the period planned. The period had been extended as per letter. No 491 of the file TP/2012/DC/NW-111 addressed to the Deputy Chief Secretary of the North Western Province requesting to extend the period of training to officers attached to the NWPC who conducted the course.

(ii) Short Term Training Programmes

Officers of other state institutions were invited for the short term training courses. There were instances where presence of officers invited become less (due to personal and other official reasons) and as such all the officers who were expected to participate were not present as planned. This is an unavoidable situation as per as the N.I.S.E in concerned. Much attention needs to be paid by state institutions offering training in this regard. This had already been brought to their notice.

(iii) Short term Training Programme relating to Management and Primary Physiology Teaching

According to the revised Action Plan, two short term training programmes were to be conducted to train 100 prison officers. Those two programmes had already been completed (As per date and circumstances file documents), 5 days from 16.3.2015 to 20.3.2015 (NISD/TD/short term/2014) (This is referred to in the revised Action Plan).



 Short Term Training Programmes for officers of the Kesbewa Divisional Secretariat

This training programme had been deleted in the revised Action Plan. (A three days training programme had been conducted for officers of the Homagame Divisional Secretariat instead of the officers of the Kesbewa Divisional Secretariat. (4,5 and 6 of March 2014) (NISD/TD/short term/2014)

• Capacity Development Training Programme for academic and non academic staff of the National Institute of Social Development.

The Programme concerned could not be conducted due to the work load of the staff and lack of suitable space facilities. However, the lecturers of the Institute had voluntarily conducted a few short term ½ a day lectures for the new academic and non academic staff recruited in 2014.

• Commencement of a Trainings Centre in Kandy.

Commencement of a Training Centre in Kandy Commencement of a training centre in Kandy had not been mentored in the revised action plan.

- (e) Social Development Policies, Research and Publications Division
 - (i) Workshop Academic Division

A two days academic workshop named 'Two days' workshop on research writing" had been conducted on 29th and 30th May 2014.

• Three months' certified course on Research Procedures

Three months' certified course on Research Procedureswas necessary for the efficiency bar examination of Research officers. It was decided included external participants too. But, there was lack of applicants and as such the course could not be conducted. Action had been taken to call for applications in future.



Diploma course in Eradication of Narcotic Drugs

According to the work programme of the Social Development Policies, Research and Publications Division for the year 2014, the Diploma Course in Social Work for Narcotic Eradication had been prepared on a proposal made by the board of directors of the National Institute of Social Development.

But, this course could not be commenced as there were no adequate number of applicants so as to commence it without giving publicity through notices.

- (iii) This activity had been performed by National Development Polices, Research and Publications Division in 2014.
- (iv) Three months, certificate course in Research Procedures.

A 3 months certificate course was planned as it was necessary for the efficiency bar examination of research officers. But, it was decided to conduct it with the participation of external applicants. But, necessary number of applicants were not available and it could not be commenced. Action had been taken to call for applications in future.

 Publication Activities relating to the Research Book on the findings of Examination of the Children's Position in hostels.

Although the publication activities relating to the research book on the findings of examination of the position of the Institute and students should have been done as per agreement. However, publication of research book was under taken by the Department of probation and Child care Services and as such we could not publish it. That would be carried out by them.

(v) Functions not Related to the Division

 Preparation of a "Sticker" on behalf of the National Institute of Social Education

According to the Corporate Plan of the National Institute of Social Education, it has been stated that one of the duties to be carried out by



the Social Development Policies, Research and Publications Division in to carry out research and it would be appropriate if publication is also carried out by the division. Accordingly it was considered that printing of stickers at present would bring more publicity to the Institute.

• Preparation of Syllabuses for Diploma in Narcotic Drugs Eradication

According to the work plan of the Social Development, Research and Publications Division for the year 2014, a diploma course in social work interference to eradicate usage of narcotic drugs was prepared on a proposal made by the board of directors of N.I.S.E.

But, there were no applicants in order to commence this course and as such it could not be commenced. The co-ordination of the board of directors had been obtained to prepare the syllabuses.

• Preparation of a Syllabus for a certified Course in Research Procedures

It had been planned to implement this course in future. As such, the syllabuses had already been prepared and ready for implementation in the ensuing years. The responsibility had been entrusted to suitable officers of that division.

• Discussions among Inter Related Institutions

According to the audit report for the year 2014, it has been pointed out that this work has no relevance to the Social Development Policies, Research and Publications Division. But, this was carried out by them so as to bring awareness about the N.I.S.E and its publications among institutions which deal with research and welfare activities. As such, it was necessary for that division and the Institution. Suitable research officers were appointed for this purpose and the work had been carried out with the approval of the board of directors.

4.2 Management Inefficiencies

(a) The loss relating to our vehicle which met with an accident had been recovered during this year. The internal board of examiners are inquiring into the other accident.



(b) Action had been taken to grant loans continuously considering the recoveries Rs.2 million obtained from the Treasury. But, this amount was not adequate to meet the increasing number of employees. In order to overcome this problem the approval of the board of directors had been obtained to grant loans from our second account whenever necessary. But, this had not been formed as a Fund. Action would be taken to pay attention in this regard as advised by you.

4.3 Weaknesses in Financial Control

- (a) Strict instructions had been given to the relevant staff to avoid such shortcomings.
- (b) The VAT letter had already been obtained and a copy of it had been filed of. An annexure is presented herewith.
- (c) One percent of the course from which fees are charged had been allocated to the welfare association. But, the payments had already been stopped after you pointed out that the welfare association cannot obtain it.

4.4 Uneconomic Transactions

The amount had already been recovered from the security branch concerned.

4.6 Staff Administration

- (a) A reply had already been furnished for your early query in this regard. However, all these posts have been confirmed now.
- (b) All the errors had been rectified now and duty lists had been assigned to all academic and non academic staff. These officers have been posted to the research division and duties assigned accordingly. However, no research officer has been assigned for work not related to him.
- (c) A reply has been furnished. The services of the professor has been suspended from 30.8.2014.
